I am writing to inform you that Timothy Charles Holmseth, a citizen in your respective jurisdictions, is a registered witness to the Judicial Commission of Inquiry into Human Trafficking and Child Sex Abuse, Sir John Walsh of Brannagh Presiding.

By copy of this letter our Commission salutes Assistant Chief Judge Tamara L. Yon who recently vacated an order against Mr. Holmseth in Minnesota, and thanks the officers of the Polk County Detention Center for listening to my emergency telephone call from Japan.

Mr. Holmseth is scheduled to testify in London on 13 April 2018. This is known. We fear for his life and we fear that steps will be taken to plant drugs in his home or vehicle. We alert you to the likelihood of adverse publicity if he were to come to any harm in the aftermath of this explicit caution. Should your circumstances permit, we urge you to cancel the two extant citations and block any future citations based on an out-of-state order that is being challenged.
