Truthful Testimony/Sworn Affidavit of Annette Rose Church

- 1) I [Annette Rose Church] sworn under the pains and penalty of perjury claim the following facts to be the truth. And that I am of age, of sound mind, and competent to put these facts upon the record. *I'm here to fight for the children. (The Trafficking Victims Protection Act (TVPA) of 2000)*
- 2) *Regarding Executive Order 13818- HUMAN RIGHTS ABUSES, Etc., Slavery*
  1. I would like to submit upon the record that I received a file, from a source on Telegram, on about January 23, 2021 which showed the true existence & evidence of Adrenochrome, but at which time, I did not review all of the pages or documents in the file, as I wasn't quite sure what to do with them. The file appeared to be hurriedly sent/shared.
  2. I testify that after seeing the file, and opening all of the pages of the document/file at about the end of February 2025, I became deeply concerned to discover that some of the pages contained lists of children's names, dates of birth, their blood types, and their Adrenochrome quality, from a report that was printed out about June 1<sup>st</sup>, 2020.     - e. Research and experimental development on biotechnology.
    - f. Activities of head offices.
    - g. Combined office administrative service activities.
    - h. Other research and experimental development on natural sciences and engineering.
    - i. Manufacture of other chemical products n.e.c.
    - j. Manufacture of perfumes and toilet preparations.
    - k. Other professional, scientific and technical activities (not including environmental consultancy or quantity surveying) n.e.c.
  3. I would like to submit upon the record that the DUNS numbers of the companies in this despicable & RICO criminal enterprise, with countless Crimes Against Humanity was documented as well, on the pages of the file. As well as, including services Coding numbers, information on quality, minimum order quantity, and their 2020 pricelist of United States Dollar [amounts] per mg [milligram].
- 3) I testify that some of the documents also mentioned the Production of Raw Adrenochrome and with the average age of [REDACTED]. Along with other incriminating details.

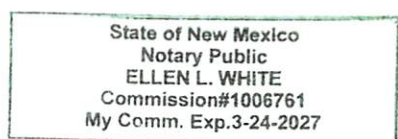
