Mr. Galstad,

A federal lawsuit is in gestation that will inevitably discover with great precision your telephone calls and emails with the parties to the Florida judgments, and your role in keeping from the Florida proceedings the information then in existence that recently assisted an honest judge in Minnesota to find in favor of Timothy Holmseth. He has been naive in relation to both the Florida and the Minnesota proceedings in which you played such an important role.

It is not my wish to engage in the minutia of justice in Polk County. I am neither an attorney nor a law enforcement officer but as a former spy recommended for the Nobel Peace Prize and with other honors and engagements, I do have my moments. It merits comment that one of the two judges passing impaired judgment on Timothy Holmseth in Florida has just been suspended. I and multiple others, including FBI officers, have found Timothy Holmseth to be a credible witness.

By copy of this email to the Polk County Commission Chair and the Mayor of East Grand Forks I am respectfully and humbly suggesting that you be removed from -- banned from -- all matters pertaining to Timothy Holmseth and that superior prosecutorial discretion be exercised in cancelling the citations that exist today against Mr. Holmseth and preventing any further citations from being issued.

I have urged Mr. Holmseth to refrain from any additional commentary -- the letter of the law must be followed pending a successful challenge to the two Florida county level judgments againsts hm -- and I will consider taking his testimony in London in camera but that measured testimony, and the judgments rendered by the international panel, will be communicated to the Department of Justice. At this time our focus is going to be exclusively on Florida -- Polk County is explicitly not to be discussed in London by my order.

It was my privilege, with William Binney, to help Jeff Sessions harvest the data on national pedophiles and pedophile protectors from the 99% of the NSA data previously unprocessed. We have it all -- the one good thing to come out of ten years of comprehensive warrantless wiretapping. Beyond pedophiles we are going after dirty cops and dirty judges. It will take time, but we are going to clean up this system and restore integrity at the county level.

It is my hope that Polk County Commission Chair and the Mayor of East Grand Forks will consider the case of Timothy Holmseth an opportunity to display ethical leadership in the public interest. I note with concern the resent media hit job of Timothy Holmseth, and would not be surprised to learn that the independent "journalist" in question received a financial incentive for running the story -- or was put up to it by a serving officer with questionable motives. I leave that to the political leaders in your area to address. From where I sit, Polk County has some housecleaning to do, and Timothy Holmseth is not the problem.

Dear Mr. Steele:

I acknowledge the receipt of your March 8, 2018 letter. I appreciate the information however Mr. Holmseth is currently in violation of the harassment restraining order issued in the State of Florida. Additionally, after being arrested he has violated the order twice after his release. His conditions of release specifically stated not to violate the order. In your letter you indicate that the Florida restraining order is being challenged. Is it being challenged in the State of Florida? Do you have a timeframe for it to be heard? Please let me know because at this time I am not at liberty to cancel the three citations currently pending against Mr. Holmseth.

On another note you indicate that Mr. Holmseth is scheduled to testify in London? I would only ask that you check the veracity of his claims. I can not speak to the claims made against the authorities in Florida, but will let you know the claims against me have absolutely no basis in fact. Mr. Holmseth has a tendency to exaggerate and jump to baseless conclusions. I only say this out of respect for your cause directed at human trafficking and child abuse. I implore that you proceed with caution because Mr. Holmseth's testimony could do more harm than good.
